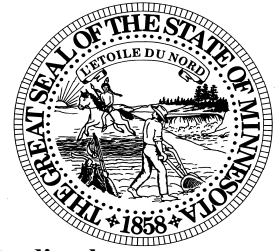

- 1. File Number:** Provide the file number issued by the Minnesota Secretary of State.
- 2. Name of Corporation: (Required)** List the corporate name on file with the Office of the Secretary of State.
- 3. Date of Incorporation: (Required)** Enter the date that the corporation filed Articles of Incorporation with the Secretary of State's office.

**Authorized Signature(s): (Required)** Must be signed by a majority of the incorporators or directors of the corporation or by an authorized agent (The signing party must indicate on the document that they are acting as the agent of the person(s) whose signature would be required and that they have been authorized to sign on behalf of that person(s).) List the additional signatures on an attachment if needed.

**Email Address for Official Notices.** This email address may be used to send annual renewal reminders and other important notices that may require action or response. Check the box if you wish to have your email address excluded from requests for bulk data, to the extent allowed by Minnesota law.
