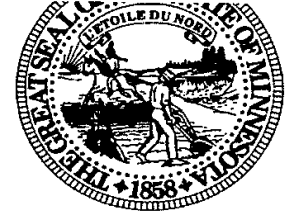

# 2016 Annual Benefit Report

## Jan. 1 – Dec. 31, 2016

OfferingTree's mission, as stated in our Articles of Incorporation, is to further wellness education and access. During the 2016 calendar year, we worked to fulfill our mission through two primary activities:

- Creating an integrated, easy-to-use online platform that supports wellness professionals in earning a livelihood and serving their clients' / students' needs
- Co-sponsoring a public event facilitated by a wellness professional that provides wellness activities and education to the public at no-cost

In September 2016, OfferingTree co-hosted a "Yoga in the Park" event with Yoga Sol. The event was provided at no-cost to the public and was attended by 30 participants who enjoyed a 60-minute guided yoga session in a public park.

In October 2016, we launched a beta version of our online platform and enrolled beta users to provide feedback on usability and functionality. The feedback from these users helped OfferingTree to redesign aspects of the platform to increase its ease-of-use and core functionality.

Since 2016 was our start-up year, the vast majority of our team's energy and time was devoted to development of the beta version of OfferingTree's online platform. This hindered our ability to co-sponsor more than one public event. In addition, our beta version of the platform wasn't ready for testing until October, so our ability to support wellness professionals was also hindered by a longer than expected development timeline. Despite these initial challenges, we still managed to accomplish two key milestones in 2016: a functional beta version of our online platform and a free public wellness event.

The OfferingTree team is excited to continue its work in 2017 to further wellness education and access. We're proud of our public benefit status and look forward to building upon our 2016 successes.
