The undersigned, Lucy Franklin, CEO of Inner Embrace Wellness GBC, hereby certifies as follows:

The board of directors for Inner Embrace Wellness GBC has:

1. Will continue to use Green America Business Network as its designated third-party standard;
2. Determined, after due and diligent inquiry, that Green America Business Network is independent;
3. Approved the report as presented to the board;
4. Determined that this corporation has pursued the third-party standards promulgated by Green America Business Network and provided a general public benefit as follows:
  - a. Inner Embrace Wellness GBC operates a "values-based" social enterprise according to principles of social justice and environmental sustainability by, among other things, providing natural health solutions to support wellness by offering holistic body work that aids the body in sustaining long-term solutions to bodily injuries, and that has expanded to working with the Avazzia device as well as partnering with a specific non-profit dedicated to providing alternative therapies to people with disabilities, to donating wellness sessions as well as 30 min clinics to unemployed who are unable to afford body work, is continuing to pursue crowd-funding for non-profit organizations to help increase their bottom line, distributing products that support wellness and nutrition and that use natural ingredients (thereby limiting the impact of pharmaceutical and chemical compounds on the environment), distributing products for companies that use a give-back business model and support health and nutrition, using reverse osmosis water as well as using cleaning methods of products that are non toxic, continuing to implement sound recycling business practices, and focusing on conversion to electronic rather than using paper.
5. Determined that the only hindrance in efforts to pursue and create general public benefit were several injuries and illness throughout the year.

6. The standards provided by Green America Business Network are being applied in a manner consistent with the application of the third-party standards in prior reports because the standards are most closely aligned with the purpose of Inner Embrace Wellness GBC.
