RESPONSES TO QUESTION 3

(1) I certify that the Board of Directors of SUM&C has chosen B Lab to conduct 3rd party assessments, and that it is independent of SUM&C. The Board approved the 3rd party report.

(2) (i) The Board utilizes the B Impact Assessment through B Lab, which independently measures social and environmental impact of businesses.

(ii) SUM&C was formed in July, 2017. The corporate formation enabled me to get the business going (phone number, PO Box, bank account, etc.). Marketing materials were developed starting in the fall and the first marketing materials were sent out in December, 2017 (a second one is planned for June, 2018). To date, SUM&C has performed no substantive work. The only funds SUM&C currently has are from my personal investment in the company.

SUM&C is organized as a general public corporation and its Articles of Incorporation state, in Article 3.2 that the Corporation shall . . . pursue a general public benefit, namely, to annually donate five percent (5%) of its net profit from its management and consulting business to support tax-exempt charitable organizations in the communities in which the Corporation provides its services." Since there has been no income or revenue earned by SUM&C, there is no net profit from which to make a donation. It is genuinely hoped that SUM&C will earn some income by the end of 2018 and thus be able to pursue its public benefit of making a 5% donation in accordance with its Articles of Incorporation.
