This report covers the period from our initial filing on 1/1/2020 through 12/31/2020. Community Hops specific public benefit purpose is: Improving local communities and connecting neighbors through urban agriculture education and training.

Our normal priority is to physically bring people together to share community and knowledge; due to COVID-19 we were unable to operate regularly in 2020.

This year we did harvest a crop of hops. We supplied those hops to a company that produces plant based extracts and they were able to produce a small run of hop oil extract. We have supplied these extracts to a number of community members for experimental use. Our hope is that we may be able to provide a new product to our members and community. We're considering this experiment something we could apply on future crops of hops. We'll pass out the resulting homebrew to members and ask for input on the success of the application as an educational opportunity.

We look forward to expanding our operation and exploring new opportunities to engage the public as vaccination rates allow it.
