A. Financial Performance

a. A.O. Williams, SBC DBA/Qonsultum SBC, has demonstrated consistent financial growth in 2023. Our revenues increased by 25%, and EBITDA grew by 10%. This signifies a solid and sustainable financial footing, promising a brighter future for the organization.

B. Social Impact

a. Our commitment to social responsibility remains steadfast. In 2023, we launched the Environmental Social Justice (ESJ) program to support small businesses and the transition to help them become more circular-focused businesses. The results? We worked with 3 small businesses and provided free circular consulting services. We spent over 100 hours working with them. This enabled them to recycle their operating expenses into other business areas to help them lower expenses and increase profitability.

C. Environmental Sustainability

- a. This year, we did the following activities to reduce our carbon footprint:
 - i. Sustainable Procurement (SP): We started sourcing goods and services from sustainable suppliers. By choosing suppliers who adhere to environmentally friendly practices, we began promoting a culture of sustainability within our supply chain. The companies used:

 - 4. DocuSign (Digitally signing documents)
 - ii. Telecommuting and Digitalization (TD): With technological advancements, we embraced remote working. We reduced carbon

emissions because employees didn't have to commute to work every day. We also reduced waste by operating a virtual office, which reduced paper waste.

iii. Employee Welfare

Our employees are our greatest asset. We introduced an 80% WFH
(Work from Home) policy supporting our remote work goals. This
lowered our carbon emissions because employees didn't have to
commute daily.
