La Dona Cervceria operated as a specific benefit corporation in 2023 for our 6th year. Our articles of incorporation describe our specific benefit as “supporting the Latino community of Minnesota and providing support to social, economic and environmental issues that affect the larger community.” In support of this mission this year we supported local charities with small donations of products for silent auction, and nearly \$1500 in direct donations. We hosted and sponsored several non-profits through events of theirs and the use of our space. We also have been supporting Latino businesses by hosting Latin vendors and aspiring entrepreneurs. We also hosted several larger events centered around Dia de los Muertos and Cinco de Mayo for the Latin community. We also worked with the MNinize initiative, to highlight their growing program to make restaurant waste become more environmentally conscious. We also supported our mission culturally by bringing back an English/Spanish conversation night. Making it Weekly in 2024.

We were hindered in our pursuit of our specific purpose in various ways, mostly due to financial hardship wrought by the construction of an apartment next door to us that has not been completed on schedule. We were able to host countless individuals from our community and various Non-Profits to host their events and Fundraisers, including many Spanish Immersion Schools. We hope to continue to grow our Cinco de Mayo and Dia de los Muertos festival and others celebrating Latin heritage and culture. As well as supporting the variety of Latin businesses we partner with to do those events.
