

Background on HumanitarianHR

HumanitarianHR was established as a Specific Benefit Corporation (SBC) on May 24, 2018 to prevent and protect vulnerable people from sexual exploitation, abuse, and trafficking.

In tandem with the global movement to end impunity for sexual harassment, exploitation, and abuse, HumanitarianHR was launched to eradicate the sexual exploitation, abuse, and trafficking of refugees, displaced people and other at-risk populations by those working in the humanitarian aid and development sector. HumanitarianHR has a diverse team of consultants helping organizations develop the highest standards to protect their staff and at-risk populations from sexual exploitation, harassment, and abuse, safeguarding dignity and restoring hope for those

HumanitarianHR services provided include:

- Safeguarding policy and practice recommendations
- Independent safeguarding investigations and recommendations
- Development of safeguarding investigation procedures
- Protection from sexual harassment, exploitation, and abuse (PSHEA) training for staff and managers
- Training for safeguarding investigators and focal points

- Development of prevention, response, and accountability mechanisms, including community-based complaint mechanisms
- PSEAH prevention mainstreaming
- Auditing of safeguarding programs
- PSEAH accountability and compliance guidance for contractors and vendors
- Ombudsman support for survivors
- Protective accompaniment for vulnerable people

HumanitarianHR focuses exclusively on helping humanitarian aid and development organizations bolster their safeguarding work to protect the people they serve and their staff from sexual exploitation, abuse, harassment, human trafficking, and other harm by humanitarian actors.

In 2023, HumanitarianHR SBC achieved a key milestone in completing its 5th anniversary of providing services to protect at-risk populations from sexual exploitation, abuse, and other harmful behavior in humanitarian settings. HumanitarianHR continued to provide most of its services through online and remote support, but also performed work on-site in international locations. The following services were provided in 2023, in conformance with HumanitarianHR's mission as a specific benefit corporation:

- Continued to conduct remote and on-site independent investigations into allegations of sexual exploitation, abuse, and harassment (SEAH) and other harm by aid workers against humanitarian and development aid recipients. Work was performed in Kenya, Democratic Republic of Congo, Uganda, Bangladesh, Nepal, Pakistan, Thailand, Somalia, Sierra
- Developed and conducted special training for Peace Corps' global security teams in conducting
- Provided surge SEAH investigation support for the World Health Organization (WHO).
- Secured three contracts with the World Bank to provide support and training for their contractors
- Supported 28 safeguarding and investigation experts globally in the implementation of
- The Executive Director renewed her Private Investigator License with the State of Minnesota.
- Any circumstances that hindered efforts to pursue or create the specific public benefit (iii)
