

President Rob Vischer, University of St. Thomas



Rob Vischer, former dean of the School of Law, began his tenure as the 16th President of the University of St. Thomas on January 1, 2023. He is the second layperson to assume the role, after rising through the ranks in the university's law school beginning as an associate professor of law in 2005. The President is responsible for the direction of the University of St. Thomas, a mission-driven institution striving to be a great place for students, staff and faculty to think, act and work to advance the common good. President John Runningen, LeadMN



John is the President of LeadMN, a prominent nonprofit organization advocating for the 100,000 community and technical college students across the state. As a first-generation college student and non-traditional learner, he faced significant challenges navigating the financial aid system, including a daunting experience with the FAFSA that resulted in his denial of aid and accumulation of \$6,000 in debt during his first year of college.

Driven by these personal struggles, John is dedicated to ensuring higher education is both equitable and affordable for all students. His leadership at LeadMN focuses on breaking down barriers and creating opportunities, so every student has the support they need to succeed.

Secretary Steve Simon, Minnesota Secretary of State



Steve Simon is Minnesota's 22nd Secretary of State. He was sworn into office on January 5, 2015, and as Minnesota's chief elections administrator pledged in his inaugural address to "work with anyone, of any political affiliation, from any part of our state" to protect, defend, and strengthen the right to vote in Minnesota.

As Secretary of State, he partners with township, city, and county officials to organize elections on behalf of Minnesota's nearly four million eligible voters, and to ensure that the election system is fair.

Simon grew up in St. Louis Park and Hopkins. He graduated with a B.A in Political Science from Tufts University in Massachusetts in 1992, and earned a J.D. from the University of Minnesota Law School in 1996.

Developing and implementing a nonpartisan democratic engagement action plan is a proven method to increase and institutionalize nonpartisan democratic engagement. During this session, we will share information about the action planning process, partners and resources to support your action plan development and implementation, and the timeline for campuses to develop 2024 action plans. We'll provide an overview of programs like the ALL IN Campus Democracy Challenge and Voter Friendly Campus initiative that support campus action planning as well as answer questions about the action planning process. Moreover, participants will be able to directly interact with campus stakeholders deeply engaged in the process of action planning. This provides an opportunity to glean insights from their firsthand experiences and benefit from the guidance they have to offer. This session will be beneficial for all individuals (students, faculty, administrators, staff, community partners, etc.) regardless of past action planning experience.

In this interactive session, students will explore how to empower trans youth to actively participate in local and state government processes - even if they aren't eligible to vote! Through amplifying youth choice and youth voice, participants will learn how to navigate the challenges faced by trans students and create inclusive spaces that honor their identities and needs. By delving into recent and potential Minnesota state law changes affecting trans rights and advocacy efforts, equipping attendees with the knowledge and tools to navigate legal challenges effectively. With a combination of discussions, practical strategies, and legal insights, students will walk away with action steps to position them as experts in their own experiences. The purpose of this workshop is to empower trans students to engage meaningfully in local government processes, ensuring their voices are heard and their rights are protected. By providing practical strategies, legal insights, and a commitment to JEDIB principles, we seek to create a more inclusive and equitable local government that reflects the diverse needs and experiences of our community.

Myrtle Lemon-Todd (they/he) is an Artist, Activist, and Community Organizer. He has worked with organizations like Queer Equity Institute, Flip the Script, QUEERSPACE collective, Minnesota trans and Intersex Resource Network (MNTIRN), currently serves as the Campaign Communications Dir. for Leigh Finke for MN, and runs their own digital communications contracting service SharkyLemon. Myrtle is a proud Transgender and Non-Binary individual and has provided training to multiple organizations around the country including: Best Buy Teen Tech Centers, GenderJustice, Foster/Adopt MN, Lutheran Social Services, Hennepin County, Ramsay County, MN Youth Collective, and more.

Young people are often tasked with saving democracy -but what if you're not eligible to vote? what if your vote doesn't feel like enough? this session explores using voting as a tool of harm reduction and presents civic engagement as a framework to critical thinking and systemchange work.

Rahhel is the co-founder and Executive Director of the Minnesota Youth Collective. MNYC is an organization centering the leadership development of the next generation of movement leaders, leveraging electoral work and issue advocacy as tactics to have a more equitable state. She started organizing her peers in college at the U of M Morris and went on to have an extensive youth organizing background. Rahhel has prioritized working with BIPOC youth without co-opting their movements, and believes in giving young people the tools to succeed.

Federal Work-Study for Voter Registration Implementation Workshop

Staff Track

The U.S. Department of Education recently clarified that Federal Work-Study (FWS) funds can be utilized to support college students in performing nonpartisan work on elections, including on-campus voter registration and assisting government agencies such as state and local election offices. This means institutions across Minnesota have the opportunity to access new funding to help students participate in the democratic process - and we want to help you take advantage! The Students Learn Students Vote (SLSV) Coalition, the ALL IN Campus Democracy Challenge, and the Campus Vote Project collaborated to develop a Federal Work-Study for Voter Registration Implementation Toolkit: a comprehensive guide addressing common questions and challenges that arise when establishing the position, as well as detailed strategies informed by campuses that have successfully established FWS positions for nonpartisan voter registration. During this session, we'll give an overview of the Implementation Toolkit and leave ample room for participants to ask auestions.
